SUMMARY OF REVISIONS: This directive supersedes NWSPD 10-22, "Readiness," dated December 3, 2003. Reword paragraph 2. Added additional information on COOP, section 4.1.2.

- 1. NWS readiness is defined as the ability of the NWS to effectively deliver its products and services without delay. Readiness is essential for the accomplishment of the NWS mission. This directive establishes policies that enable NWS units to achieve, maintain, and sustain readiness.
- 2. The NWS will develop plans to fulfill NOAA's National Security Emergency Preparedness responsibilities to include policies, plans, procedures, and readiness measures that enhance the ability of the U.S. Government to mobilize for, respond to, and recover from a national security emergency. The NWS Continuity of Operations (COOP) plans detail National Weather Service activities necessary to ensure National Weather Service essential functions are sustained without interruption in the event normal operations are compromised.
- 3. The NWS will establish and maintain service backup operations to continue its products and services in the event of communications outage, equipment or facility failure, natural disaster, or hostile action on or near field unit locations resulting in delays of product and service delivery.
- 4. The following authorities and responsibilities are established:
- 4.1 COOP.
- 4.1.1 The NWS Homeland Security Director will establish policies and procedures for NWS COOP to ensure organizational and management continuity.
- 4.1.2 The COOP assures the capability exists within the Executive, Legislative, and Judicial branches of Government to continue essential mission functions uninterrupted across a wide range of potential emergencies, including localized acts of nature, accidents, and/or terror related

emergencies.

- 4.1.3 The NWS Headquarters, all Financial Management Centers, Regional Headquarters, and the National Centers for Environmental Prediction will ensure their organizations have the capability to develop, implement, maintain, activate and execute NWS COOP policies and procedures.
- 4.2 Service Backup.
- 4.2.1 The Office of Climate, Water, and Weather Services (OCWWS) will establish national policies and procedures for service backup operations.
- The Office of Operational Systems, Office of the Chief Information Officer, and the Office of Hydrologic Development will:
 - Ensure the ability to invoke service backup of their operational systems in the a. event of equipment or facility failure, natural disaster, or hostile action.
 - Assist in developing national service backup procedural directives. b.
 - Ensure service backup exercises are performed routinely to demonstrate c. readiness.
- 4.2.3 The NWS Regional Headquarters Offices will:
 - Ensure Weather Forecast Offices, Weather Service Offices, River Forecast Centers, Center Weather Service Units, and Tsunami Warning Centers are organized, trained, and equipped to activate and operate service backup.
 - Develop service backup supplements to national procedural directives. b.
 - Ensure service backup exercises are performed to demonstrate readiness. c.
- 4.2.4 The National Centers for Environmental Prediction (NCEP) will:
 - Ensure NCEP Service Centers are organized, trained, and equipped to activate a. and operate service backup.
 - Develop service backup supplements to national procedural directives. b.
 - Ensure service backup exercises are performed to demonstrate readiness. c.
- 5. This policy directive is supported by the references and glossary of terms listed in Appendix A.
